• **Security of the material:**

- **Timeline for completion of dismantling & lifting:**

*A) The completion of dismantling and lifting of all segments of the equipment under disposal is in the **Scope of the Buyer**. Total time allotted for the entire process is **20 days** from the Letter of Acceptance. However, the actual days required for dismantling and lifting the materials maybe mutually agreed between M/s. Manibhadra Sales Corporation and the H1 bidder. M/s. Manibhadra Sales Corporation will intimate the agreed timelines to H1 bidder. Penalties mentioned in the auction catalogue will be levied on the H1 bidder for any delay related to dismantling and lifting only upon breach of the agreed timelines.*

*B) If the lifting is not completed within stipulated timeline an extension may be provided after mutual discussion between the buyer and Manibhadra Sales Corporation. After discussion, Manibhadra Sales Corporation decision in this regard will be final & binding on the buyer.*

- **INSPECTION:**

- *The buyers should thoroughly satisfy themselves about the nature, specifications, physical conditions, quantity, quality, place of existence of the materials and working conditions at site. - **DELIVERY:-**

- *Successful Buyer & his men deputed for disposal of the material(s) should report for loading in early hours in such a manner that requisite time is available for loading.
